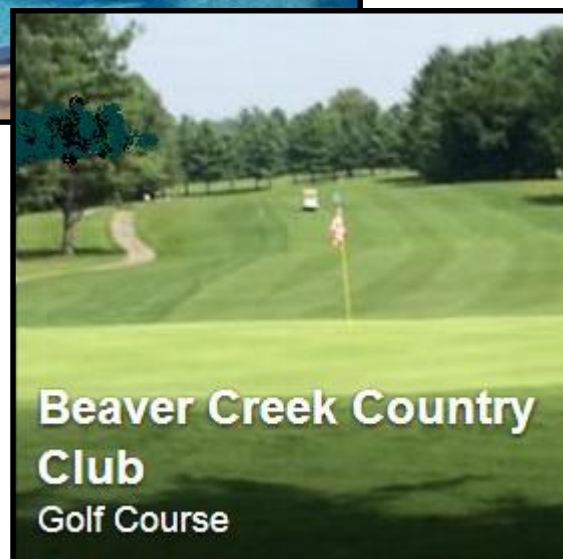

## A. INTRODUCTION

Beaver Creek Country Club (BCCC) was built and opened in 1959. Just East of Hagerstown, MD, it is conveniently located ¼ mile from I-70 (Exit 35) on MD Route 66 (also known as Mapleville Road).

The terrain is gently rolling hills. BCCC offers an 18-hole Championship Golf Course and an Olympic-size Swimming Pool. Memberships are available for both Golf and Pool.

The Golf Memberships are available in a variety of types in an effort to accommodate our various members and levels of play. The course is considered “Semi-Private”, meaning that our members have top priority in terms of usage and tee times, but we offer restricted tee times to the public during non-peak times.

Our Swimming Pool is considered “Private”, meaning it is only available to our Pool Members and their guests.

In addition to Golf and Swimming, the Clubhouse facility has the following amenities:

- 19<sup>th</sup> Hole Pub & Grill
- Private Member Room
- Business Conference Room
- Banquet Hall (240 person)
- Outdoor Wedding Site

## B. GOLF MEMBERSHIP TYPES AND PRIVILEGES

**The game of golf is a sport you can play and enjoy for a lifetime!** Very few other sports can be played from a very young age to your golden years. Golf can be enjoyed with your family, your friends or business colleagues and customers. It is a humbling sport at times, but definitely a “character builder”.

**“Handicaps”** are used to allow players of different playing ability to compete with one another. Beaver Creek’s Pro Shop offers a full-service handicap system for a nominal annual fee. Scores can be entered using our on-site computer, or via any computer or device capable of getting to the Internet. As discussed later, you must maintain a handicap through the Club to play in our Club tournaments, gangs and leagues.

**Tee Boxes:** Beaver Creek now offers eight (8) tee colors on its scorecard. The yardages vary from around 3,000 yards for our “Junior” tees to over 7,000 yards for our “Blue” or championship tees. Our Club has general guidelines for picking the “tee” that suits your game, allowing you to still have fun and be competitive as your skill set changes.

**Course Playing Time:** The standard for an 18-hole round of golf is four (4) hours. Fortunately, most of our members play 18 holes in about 3½ hours. This is a selling feature of Beaver Creek because most “public” golf courses are going to average 4½ hours. The main difference is that our members know the course and play **“ready golf”**. There are several things regarding “ready golf” which can save 30 seconds or more per shot. Multiply this by 80 strokes or so, and you will save 30-45 minutes per round, and still not feel like you rushed or played in a hurry. Most of these “ready golf” pointers are common sense, and our Pro Shop Staff will be willing to provide you some courteous tips and suggestions.

### **FULL MEMBERSHIPS:**

The “Full” membership offers you the maximum in privileges and minimum in restrictions. It is the preferred choice of most of our members for the following reasons:

- House Charge privileges are available upon request and approval.
- Full memberships allow you to play in all Club Events including tournaments and member leagues.
- Full memberships allow you to play in MISGA (Maryland Interclub Senior Golf Association).
- Full member carts are pre-discounted compared to other membership types or guests.
- The use of Power Carts is only required on Weekend and Holiday mornings before 12:00 noon.
- Full members may make **tee time reservations 2-weeks in advance**.
- Full members may bring a guest (no restrictions at this time) with the guest paying a reduced rate. To receive this discount, the guest must be accompanied by the Full Member when checking in to play.
- Full members receive a 20% discount on **Swimming Pool** dues, and the Pool Initiation Fee is waived.

### **MEMBER BLOCK PASS (10):**

Can be purchased in blocks of 10. **Considered a FULL member**. Block passes expire 1 year from purchase date.

### **STUDENT or YOUTH MEMBERSHIPS:**

- Same as a Full Member, with the exception of the pool dues. Age of 26 or less. Enrolled in an educational institute full time).

### **FLEX MEMBERSHIPS:**

- Cannot play in most Club Gangs or Leagues.
- Daily Fee is **\$35.00** for 18-holes which includes a cart. (The \$35.00 cart fee is mandatory.)
- Flex members may make **tee time reservations 7-days in advance**.
- Flex members receive a 10% discount on **Swimming Pool** dues and 25% off the Pool Initiation fee

## C. CORPORATE MEMBERSHIPS

The Corporate Membership is designed to be a flexible and affordable business tool. It is designed to have no cash outlay during your visit to the Club. Your golf, carts and range balls are “prepaid”, and the named Corporate Members each have a “house account” to allow charging of food and beverage items during your visit.

### ***CORPORATE PROGRAM (100 Corporate Passes)***

- \$4,000 per year for the Corporate Membership (\$40 per “prepaid” 100 rounds)
- Must be an approved "corporation" as determined by BCCC
- Up to four (4) "Corporate" employees can be named on the membership. Each named Corporate employee is considered a “Full Member” of the Club. This allows them to play in Club tournaments, leagues and have no restrictions on their tee times.
- Each named Corporate Employee has a “Family Pool” membership.
- Each named Corporate Employee has the privilege of “house charging” any food and beverage purchases. Monthly statements will be issued to the account holder for any house charges incurred. There is no monthly minimum required on house charges.
- One-hundred (100) Rounds per Year (includes cart and all applicable taxes). These rounds can be used by any of the named Corporate Employees and their guests.
- Nine-hole rounds are considered a half (0.5) of a round.
- With BCCC Management approval, unused rounds each calendar year are rolled-over.
- Free driving range "per round" (including guests for the day).
- Additional rounds can be purchased up-front or during the calendar year. The additional rounds will be priced at \$35.00 per round.
- Beaver Creek will allow more than four (4) named Corporate employees in certain cases.

## D. GOLF GROUPS (or “GANGS”)

Golf is definitely more enjoyable for most people when they play with friends or family. ***Playing with others also adds the element of competition.***

Because not everyone can get a friend or family member to play, or not at a convenient time, Beaver Creek offers “Groups” or “Gangs”. “Gangs” are reserved tee times set aside on a regular basis for our membership use. Besides our great “pace of play”, the Gangs are one of our biggest selling features. The majority of our members absolutely love playing in the Gangs, and would be lost without them! (Not to mention making a lot of new friendships along the way).

The size of the reserved tee times varies with the day-of-week and popularity of the gang, but we try to accommodate the varying needs by season.

Each gang has their own rules on format of play, tee boxes, handicaps restrictions, etc.

## E. RULES and REGULATIONS

**It is the intent of the management at Beaver Creek Country Club (BCCC) to limit these Rules and Regulations to the minimum required for the mutual enjoyment of the Club Facilities by all its members, immediate family members and their guests. The obligation of enforcing these Rules and Regulations for the good of all members is placed primarily in the hands of our Staff, whose principal responsibility is to assure members of all the courtesies, comforts and services to which members of this Club are entitled. It is the duty of the membership of the Club to know these Rules and Regulations and to cooperate in their enforcement.**

***“Club” refers to Beaver Creek Country Club and “Member” refers to a Member of Beaver Creek Country Club.***

1. The Fees and Dues for the various Types of Membership are available “in print” or “online”. Initiation Fees and Annual Pool Fees are not pro-ratable. Golf Initiation Fee is not refundable, but may be paid over a 12-month period.
2. Golf members pay monthly, quarterly, semi-annual or annual Membership Dues and Fees that they select to make up the type of Membership that meets their needs. New Members pay a one-time Initiation Fee and corresponding Dues and Fees for the Membership that they select.
3. A prospective Member making application to join Beaver Creek Country Club, as a Golf Member, must complete an application accompanied by the Initiation Fee, as noted, and the first month's Membership dues. This holds true regardless of which month the Membership starts.
4. A prospective Member making application to join, as a Pool Member, must complete an application accompanied by the Initiation Fee and the Annual Pool Fee.
5. Family Memberships include the Member, spouse and minor children. Minors are defined as children who have not reached their 26th birthday as of January 1st of the Dues year.
6. Youth (Student) Memberships are available for anyone under the age of 26, enrolled full-time in an educational institute, and are similar in privileges as Single Memberships.
7. Flex members must pay a cart fee each play and have some restrictions on league, group or gang play.
8. Pool Memberships provide Member use of the Pool at all reasonable times during the Season (Memorial Day through Labor Day) without payment of Pool Admission Fees.
9. Absentee Memberships provide for maintenance of Golf and Pool Memberships by present Members during an absence from the area of one or more calendar years, or a documented medical condition which would prohibit play and use of the facilities for an extended period of time. Such Members are maintained on an Inactive Roster, but do not pay an Initiation Fee when reactivating their Memberships.
10. Members shall have the privilege of inviting guests to the Club with certain restrictions. Golf Members may invite guests for Golf. Golf Members and Pool Members may invite Guests to the Pool. Members shall be responsible for registering their Guests and shall further be personally responsible for their proper conduct and for an indebtedness incurred by them in the use of the Club's facilities. Guest Fees shall be as posted in the Golf Shop and at the Pool.
11. Locker Rental Fees provide use of Half Lockers or Full Lockers in the Golf Locker Rooms and Pool Locker Rooms respectively. They are rented by calendar year, when available, and are subject to periodic inspection by Management.
12. Members in good standing are automatically continued on the Membership Roster from year to year in the same membership Category and Type that they held the previous year. They are billed accordingly and are obligated on a quarterly basis for the following year's Dues and Fees unless they do one or more of the following: a) Advise the Club in writing if they want to add or cancel a Membership privilege by the 15th of the calendar quarter beyond which they want present Membership status to change; b) Write a letter resigning from the Club to be received by the 15th of the last month of the calendar quarter which they want Membership to end. A Member who drops out of the Club without presenting a timely written resignation that is accepted, shall be automatically obligated to pay all charges that accumulate up to the time that he/she is removed from the membership roster. Non-use of the Club's facilities shall not be a valid excuse for non-payment of Dues and Fees and does not relieve those Members who do not follow the above procedures from their obligations. A Member who drops out without having presented a timely written and accepted resignation shall be denied the privileges of the Club as Guest or Competitor until his/her obligations have been met.

**A Member is considered to be in "good standing"** when his/her obligations to the Club have been met and when the best interests of the Club will be served by his/her continued Membership in the Club. However, should the best interests of the Club not be served by the annual renewal of any person's Membership, then such renewal shall not be made and that person shall be notified accordingly.

13. Any advance from one Category or type of Membership to another, and aside from increased Dues or Fees, will require the payment of the difference in Initiation Fee existing between the two Memberships at the time of the change. Memberships may be upgraded at any time, but preferably at year end, upon request by the 15th of the month preceding the month of effectivity. Downgrading of Membership by Category or Type, including resignation, can only be accommodated at the end of each calendar quarter upon notification by the 15th of the last month of the calendar quarter preceding effectivity, to assure that Membership changes are handled accurately, requests for same must be made in writing.
14. The Dues period for Full Membership extends from January 1st to December 31st. Dues are billed monthly, twelve months of the year, and are due on the first day of each calendar month. Dues and Fees, however, by Member choice, may be paid quarterly on the 1st of each calendar quarter, semi-annually on January 1st and July 1st of each calendar year, or annually by January 31st of each calendar year. Yearly Fees for Pool Membership are discounted if paid in full by April 1st, and must be paid before the opening of the pool season.
15. Bills are payable not later than the 25th of the month in which they are due. If a Member fails to pay Dues, Fees of other indebtedness, as noted, the account shall be considered delinquent if not paid within twenty (20) days after the billing due date and will be charged a late fee of \$15.00 on the 15<sup>th</sup> of the month following the original due date. Beaver Creek Country Club may take whatever actions it deems necessary to collect any or all of the delinquent balance on the account, along with any collection fees incurred, including suspension or termination of club membership. Non-payment of finance charges will be treated as a delinquent account.
16. Proper attire is required at all times. No tank-tops or cutoffs. Shirts must have collars (in-season). No denim shorts or slacks (in-season). "In-season" is defined as April 1<sup>st</sup> through October 31<sup>st</sup>.
17. Any Membership in Beaver Creek Country Club does not make the Member financially responsible for any obligations of the Club. Likewise, said Membership does not confer upon said Member any right, ownership, or interest whatsoever in any property or appurtenances of the Club. The Club reserves the right to withdraw the privilege of Membership from any Member who violates the rules, regulations or restrictions of the Club and Membership, or whose Membership renewal would not be in the best interests of the Club. The Club reserves the right to change the dues, Fees, Rules, Regulations or Charges upon reasonable notice. Where pertinent, the foregoing paragraphs shall be contractually binding upon Members holding the various Categories and Types of Membership noted.
18. All food and non-alcoholic beverages consumed on the Club Facilities shall be furnished by the Club, unless otherwise permitted by Club Management. Outside catering is only permitted with the prior approval of Club Management. **By law through the State of Maryland, ALL ALCOHOLIC BEVERAGES consumed on the Club Facilities must be furnished by the Club.**
19. Members and their guests may not abuse any of the Club's employees, verbally or otherwise. Any employee not rendering courteous and prompt service should be reported to the Club Manager or Club Management. Members cannot request special personal services from the employees of the Club.
20. Members and their guests are not allowed in the Kitchen or other service areas of the Club.
21. A membership may be suspended or terminated by the Club if, in the sole judgment of the Club, the member:
  - a) submitted false information on the Application for Membership;
  - b) exhibits unsatisfactory behavior, deportment or appearance;
  - c) fails to pay dues, fees, charges or any other amount owed to the Club in a proper and timely manner;
  - d) fails to abide by the Rules and Regulations established for use of the Club Facilities;
  - e) engages in conduct that is improper or likely to endanger the welfare, safety, harmony or reputation of the Club or its members;
  - f) interacts with the personnel or employees of the Club in an unreasonable or abusive manner.

A member shall be notified of any proposed disciplinary action and shall be given an opportunity to be heard by Club Management to show cause why the member should not be disciplined in accordance with these rules, provided the member makes a written request to the Club Management within 7 days of being delivered the notice of disciplinary action. While the complaint is being considered, the member shall enjoy all membership privileges the member was entitled prior to the complaint.



## F. SWIMMING POOL MEMBERSHIPS

### **Pool Status:**

The Beaver Creek Swimming Pool is a **PRIVATE POOL**, meaning you must be a Member, or accompanied by a Member, to use the facility.

### **Pool Season:**

Our Pool Season opens on the Saturday before Memorial Day and ends on Labor Day Monday.

### **Pool Memberships:** *(Annual rates and fees are published annually in the Spring of the year)*

We offer Single, Couple and Family memberships to the pool. Couple and Family memberships are defined as husband and/or wife, and all dependents of the husband and/or wife, living in the same household.

*\* There is a one-time joining fee (called an Initiation Fee) for the Swimming Pool.*

### **Pool Discounts for our Golf Memberships:**

**FULL Golf Members receive a 20% discount** on their annual Swimming Pool dues. They also do not have to pay an Initiation Fee to the Pool.

**FLEX Golf Members receive a 10% discount** on their annual Swimming Pool dues. They also receive a 25% discount on their Initiation Fee to the Pool.



### **Pool Highlights:**

- Pool hours are from 11am – 7pm (7 days a week) unless otherwise posted
- There is a Wading (or Baby) Pool available for the use of small children who are supervised by a parent or guardian.
- The Swimming Pool facility has a Men's and Women's set of bathrooms, showers and lockers.
- There is a Pool-level, full service Snack Bar offering a variety of hot and cold menu items, snacks and beverages. Alcoholic beverages are sold at the Snack Bar and must be purchased at the Snack Bar. **Maryland State Liquor Board prevents customers, patrons and guests from bringing in their own alcoholic drinks.**
- Initiation fees are a one-time, non-refundable fee.
- Individual members can upgrade to a Couple or Family status by paying the difference in initiation fees and dues for the year in which they upgrade.

## G. SWIMMING POOL RULES and REGULATIONS

- Our **Red Cross certified lifeguards** are responsible for the safety our members and guests. Please cooperate with them and respect their decisions. No socializing with lifeguards while they are ON DUTY.
- **Children under the age of 13** must be accompanied by an adult (age 18) at all times.
- No abusive language or disruptive behavior will be permitted.
- Admission to the pool may be refused to anyone with skin abrasions, colds, infections, or persons wearing bandages.
- All swimmers should shower before entering the pool.
- No running, pushing or ball playing will be permitted.
- **By the State of Maryland Liquor Board, no outside alcohol will be permitted to be brought in.** Alcohol is available in the concession area for persons 21 and older.
- No food or beverages permitted at poolside. Outside food is permitted in grass area or at provided tables. There will be hot food and snacks available in the concession area.
- **Glass containers of any kind are not permitted.**
- Chewing gum is not allowed in the pool.
- The lifeguard has the right to refuse inexperienced swimmers access to the deep end of the big pool.
- Floats used to teach swimming, are allowed in the big pool **IF** the supervising adult is in the pool and within reach of the child.
- The wading pool is for children age 6 and under and must be accompanied by an adult at the wading pool.
- Children under five or those not potty trained must wear an approved swimming diaper and must wear close fitting suits.
- Beaver Creek Country Club is not responsible for loss or damage of personal property.

### **Entrance Procedure & Parking**

1. All pool members will park in the front main parking lots. This club also supports a golf course, so please be courteous of noise when entering and leaving.
2. Enter and exit the pool by the gate at the rear of the clubhouse.
3. The parking lot will get very busy at times, therefore be extra careful with small children.
4. Alcohol is not permitted in the parking lot areas and may not be brought in from the outside. It is available to adults in the Clubhouse and concession area.
5. No vehicles shall be left overnight in the parking lot without permission.
6. When entering the pool, members must present their photo ID card to the attendant. All guests must accompany a member and pay a daily guest fee.
7. Membership cards shall NOT be loaned under any circumstances.
8. Lost cards will be replaced at a cost of \$5.

## **Clubhouse Rules & Dress**

1. The Clubhouse is available to pool members but dress code shall be the same as required for golfers. No jeans or cut-off shorts, no tee shirts or uncovered bathing suits. Collared shirts are required for men. Shoes are required.
2. Persons under the age of 21 must be accompanied by an adult 21 years or older to enter the clubhouse. No minors are allowed at the bar.

## **Guests**

1. Guest admissions are \$5.00 per person and can be paid at the check-in station at the time of admission. There are currently no restrictions on our guest policy. The policy on guest limitations and restrictions may be adjusted as necessary throughout the season.
2. The member registering a guest must be present AT THE POOL with his/her guest. Minors under the age of 13 may not register guests.
3. **Anyone wishing to have a party at the pool (more than 5 guests) must make prior arrangements.**

**Violations of guest rules or unauthorized transfer of membership cards may result in suspension of membership for the remainder of the year without refund.**

### **Policy on Prevention of Fecal Contamination Incidents In A Pool Or Spa**

1. Diaper-age children or children who are not toilet trained must wear special "swimsuit diaper" or closely fitting plastic pants.
2. Parents must make frequent diaper checks of diaper-age or non-toilet trained children.
3. Diaper changing is not allowed at poolside. Please use changing tables in the restrooms.
4. Bathers should wash their hands thoroughly with soap and hot water after using the restroom or after changing a diaper.
5. Bathers should rinse off in shower before entering the pool.
6. Any person suffering from diarrhea or a waterborne transmitted communicable disease shall not be allowed in the pool.
